

Regulations pertaining to the operation of Golf Carts, or Personal Transportation Vehicles

“Tractors will not be considered PTV”

All **Personal Transportation Vehicles** (PTV) must be registered and a **proof of insurance** on each vehicle listed on application form.

Exemptions:

- * Electric Power carts used by a handicapped person.
- * Bicycles

If you intend to operate golf carts, gators, or ATV's as a PTV on the Historic Santa Margarita Ranch, you must send this form in with your exhibitor agreement or bring this form when you arrive at the entrance gate in order to operate on the grounds.

Any one wishing to use golf cart, gator or ATV vehicles must be an EDGE&TA member and hold a current drivers license (16 years or older) and yellow EDGETA membership card with current 2011 sticker on it that is given out by your primary branch when you pay your EDGETA branch membership.

- ❖ Permit stickers will be held and can be picked up onsite upon arrival to grounds.
- ❖ Exhibitors who have a specific need or requirement to operate a PTV other than those listed above, in order to maintain or support their exhibit may check with the safety officer for a permit or special exemption.
- ❖ A speed limit of 5 miles mph will be observed while driving on the grounds.
- ❖ Vehicles may only carry no more than the number of passengers indicated by the manufacturer.
- ❖ Those wanting to register a PTV must include a copy of (auto policy, home owners policy, or ranch policy) naming each PTV and list the limits of the insurance carrier. Check with your insurance carrier prior to attending this show in June.
- ❖ **PTV's not conforming to the above guidelines may have their permit revoked and be banned from use on the Ranch.**
